Dear Minister Salles,

following my communication of 31st January regarding our final comments on the Decree ( I would like to send you today our suggestions regarding the second document under revision, i.e. the Project Document on the Amazon Fund. Given a tight time-line set by Minister Dr. Müller – he will meet with Prime Minister Solberg in Munich next week -, I would kindly ask you to urgently send me your final comments on both documents. We are very grateful for the chance of the telephone call on Monday 9.30 Brazilian time. We will call you.

As was discussed and agreed in Madrid, the draft project document provides the conceptual framework for the AF. At the same time, it gives guidance for the procedure of selecting, approving and implementing the concrete projects. The document attached contains additions to/comments of the draft version of the project document sent by you on 8th January, further developing the points made by BNDES in the review document provided by KfW.

Please allow me to highlight the key features important to us:

1. Consistency with the new governance structure of the fund as laid out in the draft decree
2. Consistency with possible new administrative regulations (as the changed remuneration for BNDES)
3. Deletion of the references to PPCDAM; instead, either references should be made to the new national forest policy or – as far as it should not reflect the basic principles important to us and which were mentioned by Minister Müller during your last meeting in Berlin – a mandatory preamble text. To this end, we therefore included in the text the basic principles which we had sent over to you in October after our meeting in Brasilia. Namely, the protection of indigenous and traditional peoples, the protection of conservation areas and

the focus on sustainable forms of production are key within the framework of German development policy.

On Monday we will have an interdepartmental coordination meeting in Berlin; on Tuesday we will be in Norway to learn about their position on the fund and the papers.

At the request of Minister Müller, on Wednesday we will provide him with the papers and submit a decision memo. I hope that we will be in a position to recommend the continuation of the fund.

Please note that the papers sent reflect the discussion between the Brazilian and the German side only. We have not shared our comments on the papers with Norway yet.

To be able to finalize the decision memo for Minister Müller we will rapidly need your final comment and general OK on both draft documents – the Decree and the Project Document. Only this will enable him to decide.

I therefore need to get your reaction on both papers as soon as possible. The telephone call on Monday will help in this regard, any written comment is also welcome. Looking forward to talk to you and hoping that we successfully can conclude our deliberation and restart working.
